

**OSMG Turkey Hunt/Gear Giveaway Sweepstakes
Official Rules**

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKE.

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SWEEPSTAKES ENTRY PERIOD: OSMG Turkey Hunt/Gear Giveaway (“Sweepstakes”) begins at 12:00 A.M. Eastern Time (“ET”) 3/8/25 and ends at 11:59 P.M. ET on 3/28/25.

SPONSOR: Outdoor Specialty Media Group LLC, 9 Albany Street, Suite 2E, Cazenovia, NY 13035 (“Sponsor”).

ELIGIBILITY: Open only to legal residents of the 50 United States and the District of Columbia, age 21 years of age or older at the date of entry. Subject to all applicable federal & state & local laws & regulations. Void where prohibited by law. Employees and their immediate family members of Outdoor Specialty Media Group LLC, Double A Outfitters (“Administrator”), its advertising and promotion agencies involved in this Sweepstakes, their respective parent companies, affiliates, and subsidiaries (collectively, the “Sweepstakes Entities”) are not eligible to enter or win. USE OF ENTRANT INFORMATION: By entering this sweepstakes, participants acknowledge and agree that the Sponsor and its partners may collect, store, and use the personal information provided, including but not limited to name, email address, and mailing address, for marketing and promotional purposes. The Sponsor will not sell or share entrant information with third parties except as necessary to administer the sweepstakes or as required by law.

Sponsor reserves the right to disqualify any entry for any reason, in its sole and absolute discretion, including if it finds an entrant acting in an unsportsmanlike or disruptive manner or harassing other entrant(s).

Any entries in excess of the above limit will be voided. Use of any automated system to participate is prohibited and will result in disqualification. If the Sponsor and/or Administrator suspect that an entrant attempted to obtain additional entries by using multiple accounts/identities or any other method, all entries submitted by the entrant will be declared null and void. In the event of a dispute as to the ownership of any entry, the authorized account holder of the email address or social media account submitted at time of entry will be deemed to be the entrant. A potential winner may be required to show proof of being the authorized account holder. Normal Internet access and data usage charges imposed by

your online and cell phone service provider may apply. Sponsor is not responsible for any incorrect or inaccurate information, whether caused by entrants, social media platforms, internet or technical errors, or by any of the equipment or programming associated with the Sweepstakes. Sponsor is not responsible for late, stolen, damaged, garbled, incomplete, illegible or misdirected entries. Winner must have valid travel documents (including but not limited to a valid passport) and travel on dates specified or forfeit all rights to prize. Winner is responsible for all travel and any gratuities and tip for the guide. The trip prize is subject to availability, and certain restrictions apply. Winner must follow all instructions given by the guide and their representatives at all times. The prize does not include incidental charges, medical insurance, or gratuities. If any of the Prize is not available after winner arrives at lodge due to any reason, such as weather conditions, health or physical limitation of the hunter, that Prize portion will be forfeited, and no substitute will be made. All travel, lodging, and hunting trip will be at the risk of the winner. Once the trip is booked, no changes or cancellations will be accepted. WINNER SELECTION & NOTIFICATION: Random drawing will be conducted by the Administrator on or about March 29, 2025 from all eligible entries received whose decisions are final and binding in all respects. Potential winners will be notified via email, telephone, and/or direct message. If the potential winner fails to respond within seven (7) days of notification, he/she will be disqualified, and an alternative potential winner will be selected. Upon a valid response from the potential winner, he/she will be required to complete an Affidavit of Eligibility & Release of Liability which must be signed and returned (along with any other documentation the Administrator reasonably requires for prize fulfillment) within 7 days of notification. If the Affidavit is not returned completed within the date specified or if an Affidavit is returned as undeliverable, or if the potential prize winner is otherwise found to be ineligible, or if a potential prize winner cannot accept/receive the prize for any reason, or if a potential winner fails to comply with these Official Rules, that potential winner will be disqualified.
