Official Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.**

**A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**SWEEPSTAKES ENTRY PERIOD:** The Saskatchewan Bear Hunt Giveaway (“Sweepstakes”) begins at 12:00 A.M. Eastern Time (“ET”) on 1/18/24 and ends at 11:59 P.M. ET on 4/17/24.

**SPONSOR:** Outdoor Specialty Media Group LLC, 9 Albany Street, Suite 2E, Cazenovia, NY 13035 (“Sponsor”).

**ELIGIBILITY:** Open only to legal residents of the 50 United States and District of Columbia, age 21 years of age or older at date of entry. Subject to all applicable federal & state & local laws & regulations. Void where prohibited by law. Employees and their immediate family members of Outdoor Specialty Media Group LLC, Into The Wild Outfitters, Ventura Associates International LLC (“Administrator”), its advertising and promotion agencies involved in this Sweepstakes, their respective parent companies, affiliates and subsidiaries (collectively, the “Sweepstakes Entities”) are not eligible to enter or win. The term “immediate family members” means parents, step-parents, children, step-children, siblings, step-siblings, spouses or grandparents, regardless of where they live.

Visit the URL indicated on the Sweepstakes advertisement/notification and follow all online instructions on the website entry form including providing your full name any other contact information requested on the form (if applicable) and your email address to submit your first entry (referred to as “main entry”), thereafter follow the instructions (located below the entry form) to earn additional entries (referred to as “additional entries”.) You must submit a main entry before you can start earning the additional entries.

Click on the tasks offered on the website to earn additional entries, such as:

- a) Subscribe to Outdoor Specialty Media Newsletter – one (1) entry
- b) Subscribe to Into The Wild Outfitters Email List – one (1) entry
- c) Follow Instagram Account – one (1) entry
- d) Visit Outdoor Specialty Media Facebook page – one (1) entry
- e) Download and sign-up to the Sponsor’s mobile app – two (2) entries

Limit up to seven (7) total entries per entrant. Sponsor reserves the right to disqualify any entry for any reason, in its sole and absolute discretion, including if it finds an entrant acting in an unsportsmanlike or disruptive manner or harassing other entrant(s).

Any entries in excess of the above limit will be voided. Use of any automated system to participate is prohibited and will result in disqualification. If the Sponsor and/or Administrator suspect that an entrant attempted to obtain additional entries by using multiple accounts/identities or any other method, all entries submitted by the entrant will be declared null and void. In the event of a dispute as to the ownership of any entry, the authorized account holder of the email address or social media account submitted at time of entry will be deemed to be the entrant. A potential winner may be required to show proof of being the authorized account holder. Normal Internet access and data usage charges imposed by

your online and cell phone service provider may apply. Sponsor is not responsible for any incorrect or inaccurate information, whether caused by entrants, social media platform, internet or technical errors, or by any of the equipment or programming associated with the Sweepstakes. Sponsor is not responsible for late, stolen, damaged, garbled, incomplete, illegible or misdirected entries. Entries become Sponsor's property and will not be acknowledged. Entries that have been tampered with will be disqualified.

**PRIZE AND ITS APPROXIMATE RETAIL VALUE ("ARV"):** A 5-day Guided Trophy Bear Hunt in Saskatchewan, Canada will be awarded. Prize ARV: \$4,900. The bear hunt trip is scheduled to take place between June 3-7, 2024, and winner should arrive at the camp on June 2, 2024 and depart on June 8, 2024. Prize is for winner only, consisting of:

- (a) 6-night accommodation at The Wild Outfitters Camp
- (b) 5 days of guided hunting ("Hunt") and tags
- (c) all standard meals and snack bar at camp
- (d) trophy care offered at camp
- (e) \$500 travel allowance (awarded in the form of a corporate check). Winner must make his/her own travel arrangements to Into The Wild Outfitters Camp in Saskatchewan, Canada.
- (f) Pick up/drop off at Saskatoon Airport as scheduled
- (g) selected accessories and/or hunting equipment to be provided by the sponsor which the winner may keep including full SKRE Gear Apparel Package

Winner must have valid travel documents (including but not limited to a valid passport) and travel on dates specified or forfeit all rights to prize. Winner is responsible for any travel expenses in excess of the \$500 travel allowance, any gratuities and tip for the guide. Winner is also encouraged to bring the following equipment: weapon of choice, backpack, range finder, head lamp, hunting clothing to accommodate cold temperatures and inclement weather), orange vest and hat, scent killer spray, insect repellent such as Thermocel with refills and personal gear such as hygiene products, sunglasses, medication, etc. Trip prize is subject to availability and certain restrictions apply. Winner must follow all instructions given by the camp representatives at all times. Prize does not include incidental charges, medical insurance or gratuities. If any of the Hunt is not available after winner arrives at camp due to any reason, such as weather conditions, health or physical limitation, the Hunt portion will be forfeited and no substitute will be made. Prize cannot be transferred by winner and is valid only for the items detailed above. If the prize is not available, Sponsor reserves the right to substitute prize (or portion thereof) with a similar prize of comparable value. If no substitute prize or portion of prize is reasonably available then the remaining components, if any, or if winner chooses not to receive any portion of prize, the prize shall constitute full satisfaction of Sponsor's prize obligation to winner, and no other or additional compensation will be awarded. All travel, lodging and hunt will be at the risk of winner. Once the trip is booked, no changes or cancellations will be accepted. Winner may be subject to background check and Sponsor is not responsible for any issue that causes the forfeiture of prize due to winner's records. If, for any reason whatsoever, winner is not approved to carry firearm, or in violation of the USA/Canadian hunting law (not limited to legal restrictions, physical impairment, mental disability, etc.), winner will not receive an alternate prize and will automatically forfeit all rights to the prize. Prize ARV may vary based on, among other things, availability, existing rates at time of booking. Any difference between the stated ARV and actual value at the time the prize was fulfilled will not be awarded. Winner may be subject to background check and Sponsor is not responsible for any issue that may cause the forfeiture of prize due to winner's records.

Odds of winning depend on the total number of eligible entries received.

**WINNER SELECTION & NOTIFICATION:** Random drawing will be conducted by the Administrator on or about 4/18/24 from all eligible entries received whose decisions are final and binding in all respects. Potential winner will be notified via email, telephone and/or direct message. If the potential winner fails to respond within three (3) days of notification, he/she will be disqualified and an alternate potential winner will be selected. Upon a valid response from the potential winner, he/she will be required to complete an Affidavit of Eligibility & Release of Liability which must be signed and returned (along with any other documentation the Administrator reasonably requires for prize fulfillment) within 7 days of notification. If the Affidavit is not returned completed within the date specified or if an Affidavit is returned as undeliverable, or if the potential prize winner is otherwise found to be ineligible, or if a potential prize winner cannot accept/receive the prize for any reason, or if a potential winner fails to comply with these Official Rules, that potential winner will be disqualified and the prize may be awarded to an alternate winner by random drawing from remaining eligible, non-winning entries. Attempts will be made to contact and/or verify up to five alternate potential winner. After five (5) attempts to verify a prize winner fail, the prize may not be awarded at Sponsor's sole discretion. Entrant acknowledges that the releases herein are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of such laws to preserve future unknown claims.

Sponsor reserves the right to cancel, modify, or suspend the Sweepstakes at any time without notice, if fraud, technical failures, any unanticipated occurrence that is not fully addressed in these Official Rules or any other errors or other causes corrupt the administration, security, or integrity of the Sweepstakes. all eligible, non-suspect entries received up to the time of such cancellation, and in a manner determined by Sponsor to be fair, appropriate, and consistent with these Official Rules.

**DISPUTES:** If any part of these Official Rules is deemed to be invalid or otherwise unenforceable or illegal, the balance of these Official Rules will remain in effect and will be construed in accordance with its terms as if the invalid or illegal provision were not contained herein.
